Only through continuous innovation and exploration can this unique art form fully realize its potential in the development of urban culture, infusing new vitality into the sustainable growth of cities.

Conclusion and Recommendation

Conclusion

The conclusions drawn from this research are as follows. First, as an essential art form in urban public space, sculpture plays a unique and significant role in shaping the city's image, preserving culture and spirit, and evoking citizens' emotions. Through its visual appeal and profound symbolism, sculpture not only enhances the artistic atmosphere of the city but also serves as a bridge between its historical and future cultural ties. In the context of globalization, the function of urban public spaces is continuously expanding, and sculpture, as a cultural symbol, is influencing the lifestyles and social interactions of urban residents with its distinctive charm.
